# SCOTT SVONKIN WINS NEARLY 3X AS MANY VOTES AS OPPONENT AT DEM CONVENTION

Svonkin finished a decisive first place at the California Democratic Party Convention over the weekend in his race for BOE

**LOS ANGELES, CA** -- Building on his tremendous momentum so far in his campaign for State Board of Equalization, Scott Svonkin won a resounding victory on Saturday night, winning the most votes at the California Democratic Party's annual Convention by nearly a 30 point margin - earning 47% of the vote to his opponent's 18%.

The California Board of Equalization is the only California Democratic Party office that is not elected statewide but is voted on by all of the party's roughly 3,000 statewide delegates. As such, it is nearly impossible for any candidate to reach the 60% required to earn the party's endorsement outright. While no BOE candidate in any of the state's BOE races earned the party's endorsement, Svonkin won by the biggest margin of any contested BOE candidate in any of the state's BOE districts.

Svonkin and much of his extended family spent the convention shaking hands, talking to delegates, and organizing the grassroots. Svonkin released the following statement on the results:

"Thank you fellow Democratic activists! I am thrilled and gratified to receive the support of such a large number of the people who are working every day to move California forward in a more progressive direction. I am so grateful to everybody who helped work for this outcome, but especially my wife, my kids, my mom, and my numerous other family members who made the long drive down to San Diego because they believed in the movement we're building. Just like we won the most votes this weekend, we are going to win the race for Board of Equalization by working harder than every other candidate, and by talking about our message: Reforming the BOE, cracking down on corporate tax cheats so we can fund our schools, and shining a bright light on the underground economy. I am beyond grateful to have earned the support of over 1,200 grassroots delegates who made their voices heard, and I am proud to be the choice of so many grassroots Democratic activists and clubs."
