Rep. Harley Rouda is Chair of the Subcommittee on Environment for the House Committee on Oversight and Reform. He's held numerous hearings on Climate Change, PFAS contamination and public health crisis, and on June 7, 2019, Rep. Rouda held a field hearing near the San Onofre Nuclear Generation Station (SONGS) that focused on exploring a way to safely dispose and store nuclear waste on approximately 100 sites nationwide.
